In addition to managing existing identities, Duplicate Identity Management identifies clones during the import process, preventing duplicates from even being created. You can escalate potential duplicates for review for a side-by-side comparison or automatically merge records based on information found within multiple records.

If you choose not to automate remediation, the workbench lets you easily compare identities side-by-side and select what information to update or transfer to a combined record.

Duplicate Identity Management is especially powerful for highly dispersed organizations (those with many subsidiaries, divisions, or locations), those that leverage a number of third parties or temporary staff, those that experience a high degree of merger, acquisition and divestiture activity, or organizations where there is a lot of identity movement such as hospitals and educational institutions.
