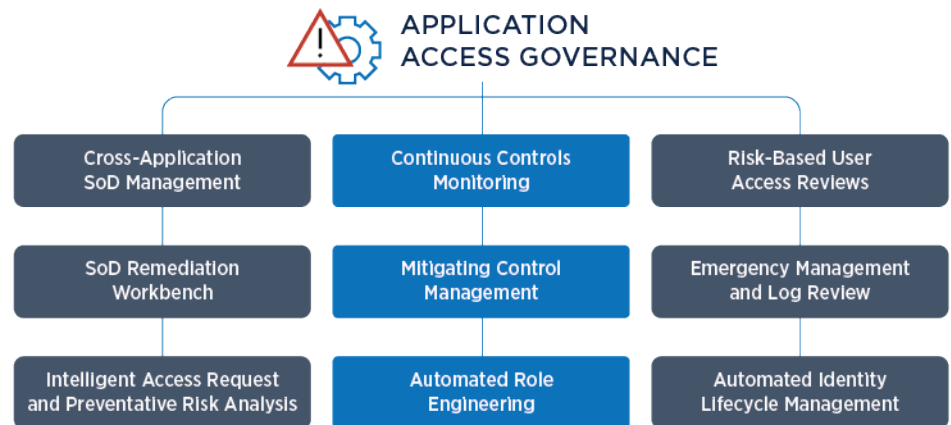
Manage SAP Cloud and On-Premise Applications from One Platform
